General Position Description: Under the supervision of the Director of Land Stewardship, the Land Stewardship Associate monitors and assesses conservation properties and conducts/coordinates land stewardship and land management activities for conservation properties. The successful applicant will be able to work efficiently both independently and in a team setting. Duties include, but are not necessarily limited to, the following:

1. Conservation Property Maintenance and Management
